PROMOTION DESCRIPTION: The Test Drive for a Chance to Win Sweepstakes (the “Sweepstakes”) begins on March 1, 2020 at 12:00 a.m. Pacific Time (“PT”) and ends on December 31, 2020 at 11:59 p.m. PT (the “Promotion Period”). The Promotion Period consists of ten (10) separate entry periods (each, an “Entry Period” and collectively, the “Entry Periods”) wherein prizes will be awarded from among all eligible entries received as the end of each Entry Period, as described herein.

Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Charter Communications Operating, LLC, with an office at 21800 Burbank Blvd., Suite 300, Woodland Hills, CA 91367 (“Sponsor”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents who are eighteen (18) years of age or older and reside in the Spectrum – Los Angeles DMA counties, including Los Angeles, Orange, Kern, Riverside, San Bernardino, and Ventura are eligible to enter. Employees, officers and directors of Sponsor, Riverside Metro Auto Group, LLC, and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “Promotion Entities”) and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize. Sweepstakes is void where prohibited by law.

HOW TO ENTER: There are two (2) ways to enter the Sweepstakes.

“**Dealership**” and collectively, the “**Dealerships**”), and follow the on-screen instructions to submit your entry and receive one (1) entry into the Sweepstakes. All requested information on the entry form at the Website must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with the privacy policy found on the Website, including, without limitation, our sharing of your information with the Promotion Entities listed herein for marketing purposes.

NOTE: Internet entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other website or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited.

2. In-person: During the Promotion Period, visit one of the Dealerships (a full list is below), participate in a test drive and complete the online entry form via the provided device at the Dealership to receive one (1) entry into the Sweepstakes.

All entries must be received by the end of the Promotion Period in order to participate. The Website’s database clock will be the official timekeeper for online entries in this Sweepstakes. In the event of a dispute regarding the identity of the individual who actually submitted an online entry cannot be resolved to Sponsor’s satisfaction, the affected entry will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error that may occur in the processing of the entries in the Sweepstakes. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

WINNER SELECTION AND NOTIFICATION: On or about each of the dates indicated in the Entry Period chart above, a live random drawing will take place from among all eligible entries received by the corresponding Entry Period end date via a Facebook Live broadcast, which will be hosted at <https://www.facebook.com/RiversideMetroAG/>. The potential prize winners will be announced during the Facebook Live broadcast and will be notified by telephone and/or mail and/or e-mail following the Facebook Live announcement, using contact information provided or collected at the time of entry. Potential winners do not need to watch the Facebook Live announcements to be considered a potential

prize winner. The names announced on each Facebook Live announcement are potential winners subject to verification of eligibility and compliance with these Official Rules. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Vehicle will be delivered with standard equipment for make and model; all upgrades and options, are at the sole cost of winner. Winner will not have choice of color. Winner will be required to show proof of currently valid driver's license and insurance prior to taking delivery of the vehicle. Vehicle will be delivered solely with the express limited warranties set forth in the vehicle's Owner's Guide.

There are ten (10) Entry Period First Prizes available (one (1) awarded per Entry Period). Each Entry Period First Prize consists of one (1) \$500 prepaid gift card.

There are ten (10) Entry Period Second Prizes available (one (1) awarded per Entry Period). Each Entry Period Second Prize consists of one (1) \$300 prepaid gift card.

There are ten (10) Entry Period Third Prizes available (one (1) awarded per Entry Period). Each Entry Period Third Prize consists of one (1) \$200 prepaid gift card.

GENERAL PRIZE CONDITIONS: No cash alternative or prize substitutions will be allowed, except Sponsor reserves the right to substitute prize(s) of comparable value if a prize listed is unavailable for any reason.
