## WHAT DOES SIERRA AUTOCARS, INC. DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and Income
- Account Balances and Payment History
- Credit History and Credit Scores

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Sierra Autocars, Inc. chooses to share; and whether you can limit this sharing.

Who is providing this notice?	Sierra Autocars, Inc., a California Corporation doing business as Sierra Honda, Sierra Chevrolet and Sierra Subaru of Monrovia
What we do	
How does Sierra Autocars, Inc. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  In addition, we maintain physical, electronic and procedural safeguards.
How does Sierra Autocars, Inc. collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>■ Apply for financing or apply for a lease</li> <li>■ Provide Income Data or Provide Employment Information</li> <li>■ Show your driver's license</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>■ Sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>■ Affiliates from using your information to market to you</li> <li>■ Sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit my sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <i>Our affiliates include Sierra Pursuits, Inc., Sierra Vehicles, Inc., and RDJC, LLC.</i></li> </ul>
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <i>Non-affiliates we share with can include auto manufacturers, we are franchised by; their vendors; other finance institutions to which we may seek to assign your contract or lease, or otherwise work with and their vendors.</i></li> </ul>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>■ <i>e.g. American Honda Finance; Ally Bank/GM Financial, Sierra Petlap, LTD; Subaru Motors Finance.</i></li> </ul>
