

# WARRANTY FOR ELIGIBLE FLEET CUSTOMERS

## COVERED AND COMPREHENSIVE

### CHEVROLET AND GMC BRAND VEHICLES

Coverages described herein are applicable only to qualified fleet customers who have taken delivery of a new, eligible Chevrolet or GMC brand vehicle in Canada.

3-YEAR or 60,000-KM<sup>1</sup>  
TRANSFERABLE BASE WARRANTY COVERAGE<sup>2</sup>

5-YEAR or 160,000-KM<sup>1</sup>  
TRANSFERABLE POWERTRAIN COMPONENT WARRANTY COVERAGE<sup>2,3</sup>

In addition to the 3-year/60,000-km<sup>1</sup> base warranty coverage, 2021 model year Fleet (rental deliveries excluded) Chevrolet and GMC passenger cars, light-duty trucks or vans come with a 5-year/160,000-km<sup>1,3</sup> (provided to qualified fleet customers who have taken delivery of a new eligible Chevrolet or GMC brand vehicle in Canada) Powertrain Component Warranty<sup>3</sup> that:

- has a \$0 deductible
- is transferable<sup>2</sup> to another owner at no charge
