INSURANCE: Vendors must carry insurance against damage and loss plus public liability insurance against injury and property of others, with limits in the amount of: \$1 million per occurrence and \$2 million aggregate, and name Reno Wise Riders INC OBA Reno H-D must have ACORD binder showing coverage and additional insured no less than 20 days before the event or space will not be guaranteed.

AGREEMENT: In signing this contract, I agree to comply with the rules and regulations printed on both sides of this contract. I understand that every attempt will be made to place vendors in the desired space. Reno H-D reserves the right to assign space on a first come basis. I agree not to relocate or sell any merchandise outside the assigned space or sub-let booth space.

SHOW RULES

1. Vendors will be assigned a load-in time. Loading begins on Wednesday, September 23rd. You will receive information regarding your load-in time 2-3 weeks prior to the event.
2. Vendors may not break down and exit the event before the event is over at 2:00pm on Sunday, September 27th.
3. Vendors must carry insurance against damage and loss plus public liability insurance against injury and property of others, with limits in the amount of \$1 million dollars per occurrence and \$2 million dollars aggregate, and name "Reno Wise Riders INC OBA Reno Harley-Davidson" as an addition insured on the policy. Reno H-D must have proof of coverage no less than 20 days prior to the event or space will not be guaranteed.
4. Vendor will deposit trash in the proper receptacles. Vendor will be billed for the collections of excessive trash or grease removal.
5. Booths must be properly manned during event hours.
6. The sale of event specific merchandise which bears the event name, dates, logos or artwork is strictly prohibited.
7. Vendors are prohibited from selling illegal merchandise.
8. Nothing containing alcohol is to be displayed or sold, unless the proper permits are obtained and permission is given by the Event Coordinator.
9. Objectionable products or actions are cause for dismissal from the event.
10. Reno H-D assumes no liability for loss or damage due to theft, fire, weather or any other circumstance.

11. Reno H-D will not ship out product nor receive product for vendors prior to the event.

12. Reno H-D does not provide phone lines, credit card downloads or electricity of the building. You can provide your own generator provided that it is quiet and doesn't smoke. Location and equipment is to be approved by Reno H-D.

13. You must provide your own tables, chairs and tents. Tents must be secured by water barrels or sand bags. **NO STAKING IS ALLOWED IN THE LOT.** Water barrels, tents, etc. are available for rent from Camelot Party Rentals at (775) 355-9004.

WAIVER

Vendor agrees to indemnify Reno Harley-Davidson, City of Reno, City of Sparks, County of Washoe, State of Nevada, all sponsors of Street Vibrations, and their officers, directors, trustees, employees, agents, representatives, volunteers and servants, and anyone else connected with the management or presentation of Street Vibrations and will hold and save each of them harmless from any and all actions, damages, and claims, to persons or property, penalties, obligations, liabilities or attorney's fees that may be asserted or claims by any person, firm, entity, corporation, political subdivision or other organization arising out of any negligent or intentional tortuous acts, errors or omissions of vendor, its agents, employees, sub-contractors, or invitees, provided for herein and arising out of the performance of this agreement. Vendor agrees to maintain booth space in a presentable manner. Vendor agrees to pay for removal of excessive trash and/or any clean-up charges necessitated by booth operation. Vendor agrees to pay a finance charge of 2% per month which is 24% per annum on past due accounts plus all costs of collection, including court costs and a reasonable attorney's fee in case suit or collection action is commenced to collect all or part of this account.
