

## **Driver Abstract Consent**

In accordance with s. 33(c) of the Freedom of Information and Protection of Privacy Act, the Traffic Safety Act, and the Access to Motor Vehicle Information Regulation, specific personal information is collected to confirm the identity of the consenting individual, to uniquely identify the consenting individual on the Registrar's system to produce the information product, and to confirm the identity of the recipient and of the authorized employee of the recipient (if the recipient is an organization). The information is collected to monitor and audit the release of information and to conduct investigations if the Registrar receives complaints about the release. A "Driver Abstract" is the product name under which the Alberta Government releases specific information from a person's driving record, which contains:

- **Current Demerit Points**
- Reinstatement

- Date of Birth
- Sex
- MVID Number
- Suspended Status
- conditions (if any)
- List of violations (Descriptions, Demerit / Merit Points and Suspension Term)
